1	The total number of sections of Bal Vatika shall be restricted to 3 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to X shall be restricted to 11. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law and availability of class rooms of greater than 500 sq ft dimension.	
2	The School is required to submit the latest land certificate shown during the virtual RC in the compliance within 3 months on SARAS portal.	
3	The school has CwSN Ground Floor Girls, CwSN first floor Boys space, which are converted by regular cubicle into cwsn and do not have enough spec for navigating the wheel chair/walker, which is not acceptable. 4	The school shall conduct training of its teachers with CoE Patna within 03 months and submit the compliance.
